BE IT ORDAINED BY THE BOROUGH COMMISSIONERS OF THE BOROUGH OF TAVISTOCK, COUNTY OF CAMDEN, STATE OF NEW JERSEY, that pursuant to N.J.S. 40A:4-53 (Ch48 P.L. 1956 as amended by Chapter 144, P.L. 1965 and Ch. 38, P.L. 1969) the sum of \$10,000.00 is hereby appropriated for the **Revision of the Master Plan of the Borough of Tavistock** and shall be deemed a special emergency appropriation as defined and provided for in N.J.S. 40A:4-55.

The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least 1/5 of the amount authorized pursuant to this act (N.J.S. 40A:4-55).

**ORDINANCE NO. 5-2021
ORDINANCE ESTABLISHING FEES TO VARIOUS LICENSES, PERMITS AND ACTIVITIES**

BE IT ORDAINED by the Mayor and Board of Commissioners of the Borough of Tavistock, County of Camden, State of New Jersey, as follows:

ARTICLE I.

The following schedule of fees is hereby established with respect to the various licenses, permits and activities required under the provisions of borough ordinances. Applications for and the issuance of such licenses and permits shall be subject to the provisions indicated for each type of license or permit. The business, activity, or operation for which the license or permit is required shall be subject to all borough regulations.
