WHEREAS, the Tavistock County Club has requested to hold a fireworks display on Thursday, June 25, 2026, at approximately 9:30 P.M. at Tavistock Country Club, 100 Tavistock Lane, Tavistock, NJ 08033 which display shall be provided by Schaefer Fireworks, PO Box 100, Strasburg, PA 17579; and

WHEREAS, the Tavistock County Club must make application for a permit from the New Jersey Department of Community Affairs, Division of Fire Safety to hold the proposed fireworks display; and

WHEREAS, the Executive Board of the Tavistock County Club has requested a resolution from the Borough Commissioners authorizing the discharge of fireworks, as required by the Division of Fire Safety; and

WHEREAS, the Tavistock County Club has confirmed that all other conditions of the public fireworks display permit have been met.

NOW, THEREFORE, BE IT RESOLVED that the Commissioners of the Borough of Tavistock, County of Camden, State of New Jersey does hereby authorize the Tavistock Country Club to hold a fireworks display on Thursday, June 25, 2026 at approximately 9:30 P.M. at Tavistock Country Club, 100 Tavistock Lane, Tavistock, NJ 08033 subject to the issuance of the permit from the Division of Fire Safety.
